

## ALHeLA Liaison Committee Report 2012

This year, at my request, a number of exhibitors applied for NNLM exhibit award funding under their institutional umbrella rather than ALHeLA's where appropriate. This allowed us to exhibit at more events since NNLM limits awards to 5 per institution. I also asked for collaboration both in terms of staffing the exhibits and in one case, joint award application from separate entities for the same event. I reminded folks about handing out the ALHeLA/InfoNet informational postcards (we still have quite a few left for exhibits.) Also, I asked that when applying for exhibit award funding, members include some funding to replenish the InfoNet water bottle supply, as we go through those pretty quickly.

In every instance my terrific ALHeLA colleagues responded positively to my requests – and the executive committee even approved a special purchase of InfoNet water bottles from ALHeLA funds (Thank you!) The following exhibits were staffed by ALHeLA members around the state in 2011/2012. (Note: not all received exhibit award funding.)

- ALHeLA received funding awards from NNLM (mostly exhibit awards) amounting to \$4152.50. This is less than the \$7000+ we received last year in exhibit award funding. That decrease is a reflection of my request to members to apply under individual institutions where appropriate, as noted earlier in this report.
- Other exhibit awards still in progress include the 2012 Alabama Academy of Family Practitioners (UAB) and the 2013 ALLA meeting in Montgomery (ALHeLA, not yet funded).

## ALHeLA Liaison Committee Report 2012 (cont.)

I attempted to make contact with someone at the state chapter of Health Occupations Students of America to ask them about collaborating on their outreach to high school students regarding health careers. However, after repeated attempts to email the contact listed on their web site (they did not include a phone number) and receiving no response, I gave up. I have also asked that we pay attention to the progress on the efforts to begin an Area Health Education Center here in Alabama, especially regarding their potential need for a librarian to serve this initiative.

Thanks to all for your ongoing contributions to marketing medical libraries and ALHeLA throughout the state!



## News from the University of Alabama Health Sciences Library

#### The Health Sciences Library at the University of Alabama Is Digitizing Historical Materials

We have started a new digitization project here in the Health Sciences Library at the College of Community Health Sciences (CCHS), University of Alabama since this spring semester. The project aims at digitizing the CCHS historical materials and institutional archives, and making them available online for the UA community.

Since CCHS first began, many historical documents and items have been produced by the college or received as donations. These historical materials include documents about the college, personal medical equipment, manuscripts, inventions, and creative works from current and former faculty members, alumni, and local physicians. These include doctors' surgeon kits, diaries, drawings, photos, video clips, music, correspondences, office memos, books, and yearbooks. These items have been saved in various departments and areas around the college, but there is currently no established collection. Now the Health Sciences Library is excited to start the digitization project to make a difference. We will establish a digital library for the history of the CCHS as well as collect and store these historical items in an organized manner in the CCHS building.

In addition, we are collaborating with the School of Library and Information Studies at the University of Alabama. We offer internship and volunteer opportunities for SLIS students who are interested in archiving and digital libraries to gain hands-on experience. We are glad to learn that one of the students who volunteered in the project this past semester thought she learned a lot and had fun working on digitization of the collection.

On our CCHS 40<sup>th</sup> Anniversary on April 20-21, we had a mini exhibit to showcase the historical collection we were digitizing as a sweet surprise to our guests during the celebration. It was encouraging to receive all the positive feedback from our alumni and community members. The project is funded by one of our generous donors. It will be our ongoing effort to preserve archives and collections that represent the history of the college. This project will increase the accessibility of our collection, which is unique to the College of Community Health Sciences and our community. Our alumni, medical students, residents, and faculty, as well as other interested individuals, will have easy access to these materials.

#### **Biomedical Library Wins Distinguished Library Award**

The Biomedical Library was awarded the Distinguished Library Award from the Consortium of Southern Biomedical Libraries (CONBLS) for participation in Our Neighborhood Healthcare Clinic, a nurse-managed clinic that provides health and wellness services to patients by collaborating with different community agencies. Funded by a HRSA grant and run by the University of South Alabama's College of Nursing, wellness clinics have been established in two community agencies serving traditionally underserved populations: 15 Place, a day shelter for homeless people, and the Dumas Wesley Community Center, an urban community center with programs for senior citizens and formerly homeless women and their children.

In 2010, Clista Clanton applied for and received an express outreach award from the Southeast Atlantic Region of the National Network of Libraries of Medicine. With the intent of promoting clearer communication between health professionals and patients at the nurse-managed clinics at 15 Place and Dumas Wesley, she works as an embedded librarian for 4 hours each week at both sites. She purchased netbooks and printers for each location in order to provide consumer health information and education at the point of care, to promote health literacy and evidence-based practice, and to track patient data. Additionally, she teaches quarterly computer literacy classes for the new residents of the Sybil Smith Family Village, a residency program for formerly homeless women and their children that is part of the Dumas Wesley Community Center. Another librarian, Andrea Wright, volunteers weekly in the computer lab at the Sybil Smith Family Village to keep the software up-to-date and the computers running. She is also available for computer or research help. In addition

to helping with research for homework, she has helped people fix their own computers and mobile devices, set up Facebook pages, fill out on-line applications, and learn basic computer skills.

Clista has continued to work at the clinics after the award period ended. The work at 15 Place is now serving as a pilot for inter-professional team collaboration project. Physician assistants, emergency medicine technicians, and social work students are currently rotating through the clinic, with physical therapy students joining soon. With the goal of building therapeutic relationships by using motivational interviewing techniques, student teams are led by the nurse manager and the librarian. Additionally, the nurse manager and the librarian are currently conducting a qualitative research study on homeless people's experiences with healthcare providers.

The collaborative efforts between the nurse managers of the clinics and a Biomedical Library librarian at 15 Place and Dumas Wesley have resulted in presentations at the national, regional, and state levels.

## News from the Princeton Baptist Medical Center McMahon-Sibley Medical Library

The past year has been a time of exciting changes and growth at the McMahon-Sibley Medical Library. After much discussion and research, the hospital library at Princeton Baptist Medical Center has decided to expand into the clinical realm. Twice a week, I join the newly formed hospitalist team in table rounds. The goals are to answer quick clinical questions, and to make note of topics and questions that need further research using an iPad. Rounds typically last between thirty minutes and an hour and fifteen to twenty patients are discussed.

The hospitalist team is comprised of one attending, one upper level internal medicine resident, two IM or transitional year interns, and a pharmacist. This rotation began with the first month of the new academic year and seeks to provide residents who are interested in the rapidly growing field of hospital medicine a training ground. The rotation is unique in that it not only focuses on teaching medical skills and patient care, but also on learning *how* to be a hospitalist. Topics covered include politics in the hospital, billing and insurance issues, Joint Commission requirements and core measures, ethics, and caring for difficult patients and families. I have been able to further this by providing literature and news articles on various aspects of business in medicine. I also keep a copy of the Joint Commission Core Measures in the library for residents to familiarize themselves with.

I occasionally join the team on the floor for bedside rounds and have been able to answer many point-of-care questions; however, I have found that I am more useful and use my time more efficiently during table rounds. Participating in bedside rounds has been a wonderful learning opportunity. I get to see how the physicians operate in their field and how many of the things I research are put into practice. This has shaped how literature searches are conducted and the way I seek to answer clinical questions.

By participating in the clinical side I am not only assisting my team, I am also marketing the library to the hospital at large. I have seen a dramatic increase in library traffic since June and have had physicians stop me both in the halls and in the physicians' lounge to request articles or a literature search. This experience has opened up new possibilities and opportunities for marketing the library.

This fall has also seen the introduction of a new case-based learning style of conference. I attend these monthly conferences armed with my trusty iPad to answer questions and make notes on any concepts that need further research. As I do with rounds, I return to my office, find articles or helpful resources to answer the questions, and then distribute it to the faculty and residents via email.

The rest of this calendar year has me looking to expand awareness of library services to Baptist Health System's three other hospitals by attending annual medical staff meetings and office managers meetings. This is completely new for the library but I am very excited to be able to widen our reach and promote our resources to physicians at other hospitals. I am also in the final stages of preparing a library user survey so I can better serve users and make changes as we head into 2013.

#### **Alabama Health Literacy Coalition Forming**

Its purpose is generally to communicate the importance of health literacy in promoting optimal health and to encourage collaborative efforts to address the issue.
