MINUTES

The Executive Committee of the Alabama Health Libraries Association met on April 15, 1994, at the Veterans Administration Medical Center, Montgomery, Alabama. Attending were Judy Burnham, George Marangoly, Jay Harris, Joe Moudry, Kay Hogan, Susan Seay, Mike Perry, Robert Avant, Joy Harriman, Pat McGee, Diane Williams, Tamara Lee, and Mary Fran Prottzman.

The meeting began at 10:30 AM. George Marangoly presented a ten minute excerpt of a VA satellite teleconference in which Chris Jones, Chief, Library Service, Veterans Administration Medical Center, Biloxi, Mississippi, demonstrated the library's role in the 1994 JCAHO standards.

The minutes of the last meeting were approved as published with the following changes: Lisa Rains is Lisa Russell; and changes to the bylaws must be published five days prior to action by the Executive Committee.

Martha Tillotson presented the Treasurer's Report. As of April 13, 1994, our balance is \$2,620.46. While our tax exempt status prevents us from selling advertisements for the *Directory*, acknowledging donations is permissible.

Judy Burnham presented the report on the 1994 Annual Meeting plan. Potential meeting sites at the Ramada Conference Center, the Radisson Admiral Semmes, and the Holiday Inn-Downtown Historic District and potential speakers were discussed. The program theme is "Leadership Challenges During an Age of Change". Entertainment by Krewe de Bienville and the

banquet at Bellingraph Gardens at \$15.00 per person were reviewed.

Committee Reports

Bylaws/Handbook

Motions to amend the bylaws as published in the minutes of the last meeting were restated and unanimously approved:

1. the immediate past president will serve as chair of the Nominating Committee for the next year;
2. all members of the Executive Council are voting members.

Continuing Education

Tammy Lee reviewed suggestions for the CE course at the annual meeting. Various options were discussed including SOLINET's Leadership Skills, ARL's Leadership and Learning, the Snowbird Leadership Institute, and [a presentation by] Carl Joiner, Dean, Business Management, Mercer University.

Directory Committee

Mike Perry presented the ALHeLA Directory Committee report, including committee goals for 1994, and requested input on redesign of the questionnaire.

Liaison Committee

Membership Committee

Jay Harris presented the Membership Committee Report. Dues for three institutional and nine personal members have been received to date. Mailing labels on future issues of *Synapse* will indicate when it is time to renew.

Joe Moudry was complimented on the last issue of *Synapse* and was requested to distribute future issues via Internet in addition to the regular mailings. Joy Harriman suggested the dedication of a special issue to library activities through-

out the state which promote the flow of medical information; the issue could be used as an institutional marketing tool. The deadline for the next issue of *Synapse* is May 15.

Union List Coordinator

Robert Avant reported that they are behind on title cessations from NLM due to a shortage of staffing. Two delinquent medical libraries who were on the verge of being deleted from the Union List have submitted updates.

Special Committee Report: NLM Internet Access Grant

Joe Moudry reported that it is not feasible to meet the May 15 deadline this year for the grant application but that plans would proceed for next year. In the meantime, he offered to develop a packet of commercial vendors for individual access.

UA HEALTH SCIENCES REFERENCE LIBRARIAN RETIRES

Barbara Parr Doughty, reference librarian at The University of Alabama Health Sciences Library for more than nineteen years, retired June 10. She was also an Associate Professor in the College of Community Health Sciences. Her decision to step down was based on the early retirement plan offered by the University this year. Barbara was an active member of ALHeLA and served as president in 1991-92.

Barbara began her work in the Health Sciences Library in August, 1973 as a graduate assistant. Upon receiving her MLS in December, 1974 she was named reference librarian, the position she has held since that time. She began her career with HSL when it was located in Gorgas Library, the main library of the University, and has seen the Health Sciences Library grow and move into its present location in the Educational Tower of DCH Regional Medical Center. During her tenure at HSL she has trained sixty graduate students in medical librarianship.

Barbara's plans for retirement include gardening, traveling with her husband Julian, and spending lots of time with her three grandchildren, who will be moving to the Tuscaloosa area soon. Anyone who knows Barbara also knows she will be devoting time to her Dalmatian, Dixie. Barbara's friends and colleagues in medical librarianship will miss her reference expertise, calm manner, and delightful sense of humor.

- strengthening the professional skills of Alabama health information personnel by providing opportunities for continuing education;
- facilitating communication among Alabama health library personnel through a program of publications; and
- convening at an annual conference and business meeting of the members of the Association.

The Bitnet discussion group ALHeLA was established as a medium of communication and mutual exchange of information in the Health Sciences in the state of Alabama. The above is the announcement that was submitted to the NEWLIST group on Internet. NEWLIST is the formal channel of announcements of newly formed, modified, or deceased discussion groups on Bitnet.

An extra benefit for ALHeLA members who subscribe to the ALHeLA List is the automatic reception of an ASCII (i.e., plain text) edition of *Synapse*. This "edition" is sent before the printed edition goes to press. All ALHeLA members subscribing to the Bitnet List will also receive the regular, printed, edition of *Synapse*, sent by normal mail. As this issue of *Synapse* goes to press, there are thirty-two subscribers to the ALHeLA List. Nine of the subscribers are current members of ALHeLA, and no less than eight are from outside of Alabama (the most remote being in Greece and Australia).

SHORT TOPICS

In April the University of South Alabama Biomedical Library participated in the campus-wide Educational Technology Poster Session Seminar. Participants in the seminar sought to demonstrate how technology is used in instruction on campus. Judy Burnham demonstrated the portable library instruction unit that is used by Nursing & Allied Health Professions. Using

a laptop computer, overhead projector, LCD unit and VCR, the various instructional segments were demonstrated. The software used included *Harvard Graphics*, *Procomm*, and *Grateful Med*. Future plans call for using a CD-ROM player hooked to the laptop to demonstrate in the classroom searching strategies for the CD-ROM systems.

Judy Burnham is serving as supervisor of a research project being conducted by three students in the Department of Physical therapy in the College of Allied Health Professions. The students are examining the publications in the journal *Physical therapy* from 1966 through 1993 using bibliometric analysis. Citations for articles published in the journal and their subject headings were downloaded from the MEDLINE database in chronological subsets. These citations and subject headings were then imported into the *Papyrus* reprint management program. The subject headings were printed out for each subset, with the number of times that subject heading was used. The final result will be reported in the form of a poster session at the College of Allied Health Professions Poster Day in May.

Every two years the Alabama Health Libraries Association puts together a directory of Alabama health information sources. We'd like your contributions listed, too.
