MLA in Seattle recently on ALHeLA's collaboration with the Medical Association of the State of Alabama (MASA) and the Alliance for Continuing Medical Education on last year's MASA workshop and Manual publication.

Speaking of the Manual, there was some consternation within the Executive Board on what to do with the remaining thirty or so Manuals that were printed by ALHeLA right before the Alliance for Continuing Medical Education approached us about publishing it. Although the "older" MASA Manual doesn't actually predate the Alliance Manual by more than a few months, there were a few changes made just before they went to press with it. Ultimately, the Board felt that selling the MASA Manual might not be the right thing to do. So, it was decided to offer the manuals as an incentive to early registrants for the 1997 annual meeting.

Pat Higginbottom, Program Chair/President-Elect, has been busy tying up loose ends on the annual meeting. As you can see from her article, all the pieces are in place for a great meeting! Diane Whited and Tracy Powell, Continuing Education Committee co-chairs, have also finalized the details on the CE offering at that meeting, "Marketing Your Library," with Mary Marshall of Lexis-Nexis. ALABAMA HEALTH LIBRARIES ASSOCIATION EXECUTIVE COMMITTEE MEETING

June 13, 1997

Kay Hogan, President, called the meeting to order at the Alabama Public Library Services, Montgomery, AL at 10:45 a.m.

The reading of the minutes was omitted as the members had already seen them. There was one correction as to the spelling of the name of Marian Morris, after which the minutes were accepted.

OLD BUSINESS

MASA Review Kay Hogan reported for Judy Burnham: The question that was tabled last meeting was whether to continue submitting articles to Alabama Medicine, with its title changed to MASA Review, by ALHeLA members. Having reviewed the first issue of MASA Review, which has a different format, Judy recommended that ALHeLA members continue to submit articles, as there are some original articles in the journal. However, prospective authors need to keep in mind the focus of the journal and the short length of the articles. Judy suggested that the articles be submitted individually with a note in the cover letter that you are an ALHeLA member. It was agreed that we follow Judy's suggestions.

Internet Class Kay Hogan reported for Judy Burnham that the workshop has been expanded to health professionals and will be held at APLS on June 17. Martha Verchot and Judy Burnham will conduct the class. Robert Avant will handle local arrangements, registration and refreshments. APLS is going to supply an Internet connection and projection equipment. We are going to distribute disks with a bookmark file of major medical sites along with handouts. Kay Hogan is working on a grant application that will provide funding for additional classes throughout Alabama. Robert Avant reported that there are 13 or 14 signees and he was considering a cutoff point. It was felt that cutoffs would not be necessary. Martha Verchot reported that skills of the signees are at various levels. Most physicians have some experience with the Internet. Kay thanked Jan Burns and Inez Pinkard for their help with publicity. There was a brief discussion of the hands-on class to be held in November at Alabama Technacenter. Fees will probably be \$25.00 A discount will likely be offered. Robert Creel and Mary Payne will assist with the setup. Martha will confer with them at the Technacenter today.

Regional Health Sciences Library Association Exchange Kay Hogan reported for Tammy Lee that a flyer with plans for the Round Table luncheon was distributed to the Board members. It gave details of the session. Help from members is needed to take certain items to the meeting. Diane volunteered to take pictures. Kay Hogan will carry the

scrapbook and directories. Others may be asked to help. Discussion concerned the need for a facilitator and secretary for each table of eight. Tables should be clearly marked. There should be a list of tables with signees and a list of signees with tables. Alabama, Georgia and Florida are the only participants so far. Publicity will be in Southern Expressions.

Ad Hoc Committee on Recruitment and Training of Medical Librarians No report.

ALHeLA Library Student Award The award will be given for one year and it will be decided if it should be continued. Someone at the UA Library School should be asked to assist with the application process and with publicity. It was announced that a new professor, Mr. McCall, is expected at UA in August and his interest is medical librarianship.

NEW BUSINESS

NNLM/SEA Grant - Internet Training Class for Health Professionals Kay Hogan passed out copies of her grant proposal. Plans are to conduct five classes in different sections of the state to educate state health professionals in the use and values of Internet resources. The hand-on class planned for November is included in the proposal. A classroom with Internet access is needed in the Dothan area. Several locations were suggested to be investigated. Bob Schrimsher will check on possible facilities.

ALHeLA Achievement Award The Awards Committee reported and made suggestions which were discussed by the group.

SC/MLA 2000 The board voted to participate as a cosponsor of the meeting with University of South Alabama Biomedical Library. The amount spent at the last co-sponsored meeting is not known. We should request funding from vendors for activities. It was pointed out that a speaker is needed.

MASA Manual Update In a written report Judy burnham reported that the manual is now being marketed by the Alliance for Continuing Medical Education. At MLA several people noted that they had attended a recent CME meeting and that the manual was for sale at the meeting. \$25.00 is being charged for the manual with ALHeLA receiving 15% royalty (\$3.75 each). Judy did a poster at MLA on the development of this project along with results of a survey of state health information professional groups on a formal basis. Several people at MLA indicated an interest in doing a similar project with their state group. Judy intends to submit this to the Bulletin MLA in the form of a Brief Communication.

Treasurer's Report The report was made by mail after the meeting since Martha Cook was absent. The ending balance was \$4,786.57. Expenses were for postage (\$24.64).

COMMITTEE REPORT

Membership Marian Morris reported a total of 63 members with several others expressing interest. A current list was distributed.

Directory Betty Wyman reported expenses of \$800.00 for last year's directory. The new directory is being developed. Input as to what members want in the book is needed. The Bylaws and Handbook will be given to the committee for the 1998 edition which is due in 1999. Suggestions were to list what institutions have Internet access, members' areas of expertise and those willing to teach a class. The information survey should be reviewed for updating. Essentials only should be requested. E-mail distribution of the survey was suggested, but Synapse will be used this year.

Liaison Martha Verchot has talked with Robin Ross and found that her interest is in quality filtering and low-literacy materials on diabetes to be made available to doctors for patient use. She is less interested in housing of materials than in a pathfinder to suitable resources. Betty Wyman and Joan Lukins can offer some help and it was suggested that she also contact the Alabama Diabetes Association.

Bylaws/Handbook Bob Schrimsher stated that since no significant changes have occurred at MLA level, he feels that none is needed in ALHeLA Bylaws. His recommendation is that the Bylaws remain as is.

Synapse Jie Li requested input from members for the publication. The next deadline is July 11.

Union List Robert Avant gave thanks to Valerie Gordon for putting Alabama MD in the Union List. He is a little behind on NLM name changes. He announced that Baptist Hospital has a new medical librarian, Becky Purdom.

Continuing Education Diane Whited has contacted Bonnie Snow of Dialog for a drug information workshop, but the expense was more than we would like to undertake at this time. Mary Marshall of Lexis-Nexis has agreed to present a six-hour workshop on library marketing at our Guntersville meeting. Tracy Powell will send an E-mail message to get CE credits from MLA. It was suggested to give out application forms at the class to apply for MLA credits.

Member-at-Large No report.

1997 Annual Meeting Pat Higginbottom distributed a printed report to Board members. Highlights are: Theme: In

a Different Light: Making Your Library Shine. Dates: September 4-5, 1997 at Lake Guntersville State Park, Guntersville, Alabama. 40 rooms are reserved and must be engaged by 30 days before the meeting at a cost of \$60.00 - 98.00 per night. Banquet price is about \$11.00-15.00 per person. Keynote speaker: Herbert S. White. Continuing Education class by Mary Marshall is at \$60.00 for members and \$80.00 for nonmembers.

The meeting adjourned at 12:45 p.m.

Internet Training for Health Professionals Grant

ALHeLA has submitted an application for the National Network of Libraries of Medicine, Southeastern/Atlantic Region Internet Training for Health Professionals Grant. The purpose of this grant is to improve health professionals' understanding of the Internet and its applications, and it is primarily geared toward unaffiliated, rural and/or minority health professionals. The ALHeLA proposal, if funded, would provide one day, hands-on classes in five different towns in Alabama: Montgomery, Tuscaloosa, Auburn, Huntsville and Dothan. Judy Burnham, Past President, and Martha Verchot, Liaison Committee Chair, would teach most of the classes, with Mary Fran Prottzman, Liaison Committee Member, as an alternate instructor. The grant amount requested is the maximum \$2000.00 award with any excess costs covered by registration fees. Continuing education credits will be sought from the appropriate authorities.

We feel that this would be a worthwhile project in fulfillment of ALHeLA's mission to promote the sharing of health science information resources and services in Alabama. If the project is not funded by the grant award, the Montgomery class will still go on as scheduled in November, with the possibility of other classes added according to costs and demand. Thanks to ALHeLA members Lee Clemans-Taylor, Pat McGee, Bob Schrimsher, Mary Fran Prottzman, Tammy Lee and Martha Cook for their help in scouting out electronic classrooms in their areas. Thanks also to Judy Burnham, Martha Verchot and Mary Fran Prottzman for agreeing to teach the classes. Let's keep our fingers crossed that we get the grant!

MLA Restructures CE Program: Part I

MLA is implementing a new CE program, which replaces the old system of roster courses, revises the guidelines for journal clubs, and introduces a self-directed learning program. The changes affecting CE courses are described below.

Under the old CE program, MLA roster courses were developed by MLA members at the request of the Continuing Education Committee. Once accepted, syllabi were reviewed every three years by the developer or another individual with appropriate subject expertise. The developer was paid a fee for the course, which was owned by MLA. Other interested instructors could apply to be certified to teach specific MLA roster courses. When a roster course was taught, the syllabi were purchased from MLA, and sponsors negotiated a fee for the course with the instructor, and MLA contact hours were automatically awarded. The developer of the course received a small fee from MLA when his/her course was taught.

Under the newly developed program, ownership of a roster course is offered to the developer as the course comes up for its periodic review. It is then up to the owner of the course to maintain it, market it, apply for MLA contact hours on an annual basis, and set the cost for teaching the course.

Chapters and state organizations often request a specially-designed CE program rather than selecting an existing course from the MLA roster. In these cases, instructors may teach a given course only once, and will have little incentive to pay the fee or complete the paperwork to obtain MLA CE credit. The application for MLA credit states that the application should not be completed by the sponsoring organization. However, individuals may apply for credits as part of the Academy of Health Information Professionals portfolio by completing the Individual Participant Request for Approval (IPR) form. This method of receiving MLA credits will be used for the CE course at the upcoming ALHeLA annual meeting; participants will receive a completed IPR to include with their next AHIP portfolio.

FREE MEDLINE!

MEDLINE is now available free to all Web users, the National Library of Medicine announced at a June 26, 1997 press conference. PubMed, an experimental Web-based system for searching MEDLINE, was unveiled at this press conference as well. PubMed, which is geared toward non-registered users, allows access to MEDLINE and Pre MEDLINE only at this time. However, by using PubMed, the public may follow hypertext links between MEDLINE citations and publishers of full text articles on the Web, as well as links to GenBank, the molecular biology database of DNA/protein sequences. Registered users may still access MEDLINE as well as some other MEDLARS databases free via Internet Grateful Med, but other non-Web-based methods of access will continue to incur charges for the time being. Additionally, full access to the resources, electronic and print, of both sites of the Biomedical Library are available with membership, including the full MEDLINE and CINAHL databases (for an additional fee).
